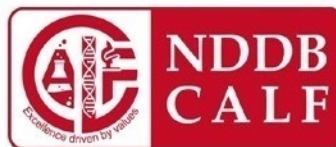

***Note for Participants >>**

1. Participants shall contact ptcalf@nddbcalf.com to get the quotation/proforma invoice for particular PT round.
2. To confirm the participation in the PT round/program, participants have to submit/email duly filled “PT Registration Form” along with participation fees in advance **(100% Advance Payment)**.
3. The information received from participants is kept highly confidential. However, when required by law or regulatory bodies or NABL, NDDB CALF Ltd. may share the PT records to the respective body.
4. While making online payment, PT round number shall be mentioned in the “Purpose of Payment” column & transaction details shall be shared along with registration form.
5. Indicated dates of PT sample dispatch are tentative and subject to change. Any change in the PT schedule would be intimated to the participants.
6. The PT round will be initiated only if the sufficient participation is received.
7. Sample shipping charges outside India will be charged at actual from the participants and any customs clearing charges in importing country will have to be borne by participating laboratory.
8. The final tax invoice would be generated and sent along with the PT sample. No refunds will be given for failure to take part in any program after registration.
9. Assign value and performance evaluation will be done based on the criteria stated in ISO 17043 and ISO 13528.
10. PT reports & certificates will be circulated to participants in the form of soft copies (Pdf format) only on registered email id.
